MANAGEMENT TEAM MEETING

April 23, 2010

Paul Ellinger: Encourage more people to get involved. For example, producing The Troubadour is too much for any one person but a committee of several people might have better luck spreading the duties among multiple people. We need to be at a point where multiple people are working on it. Make more approachable.. Need to start selling the camaraderie more, not contest. Serwach suggested establishing a Pioneer District Facebook page and did so after the meeting, soon attracting more than 300 fans, more than any other district fan page in the Society. Lewis asked if something similar to LiveWire could be done

to communicate with members. He said he would like to see the paper one go away with copies being printed out for the small number of men not on email.

Jerry Ditto: Am excited about upcoming Grand Rapids convention. Amway didn't want us (can't sing after 10) but at Crowne we were quite welcome. The auditorium is very nice, a short drive and a good fit. Did spend time looking at Lansing. Nothing's worked out yet. We're booked through 2013, looking at 2014 now.

Don Slamka: also getting a lot of people involved with efforts. Got a bunch of materials would like to put on web site. Lewis asked if there are good materials on how to help chapters find good directors when they are in search of one.
