





LEO FOBART, Editor of the Society's magazine, Harmonizer, for more than 140 issues, died in his sleep April 2, at the age of 61.

LEO joined the Society in 1953 and was actively involved at chapter and district levels. He organized and was a charter member of the Steven's Point, Wisconsin Chapter. He served as chapter president and area counselor. He was Land O' Lakes District Treasurer for many years before becoming District President in 1961.

He came to the International Office in December of 1961 and picked up the reins of the International magazine. As editor, he also served as PROBE Secretary-Treasurer from 1963 until 1980.

Memorial services were attended by many, including Land O' Lakes District President, John Bauer. The Schmidtt Brothers, 1951 International Quartet Champions, sang at the services.

The meeting, held at the Briarwood Hilton Lun, Ann Arbor, Michigan, was called to order by President Gougeon at 1:00 PM.

PRESENT: All Directors were present.

Also present were: Byron C. Davis, Robert Dixon, George Dyer, James Horton, Larry G. King, Paul Lehmkuhle, William P. Pancher, Robert Rehe, Art Schulze, Bill Tobias and William C. Warmer.

Director of Music Education opened the meeting by leading the singing of "The Old Songs."

The MINUTES of the meetings held on October 14, 1983, and December 3, 1983, were approved as distributed and published.

TREASURER'S HEPORT: Treasurer Schneider submitted the Treasurer's Report, dated March 31, 1984, showing a balance of \$6,221.08 as of that date.

OFFICERS' HEPORTS: Upon motion duly made and seconded and the unanimous wote of the Board, the C.ficers' Reports as previously distributed were accepted in accordance with the "Consent Calendar" adopted by the Board of Directors in its meeting of April 23, 1983. Copies of these reports will be on file in the Secretary's office.

<u>COMMITTEE REPORTS:</u> Written reports were received from the chairmen of the following committees: A.I.G. Scholarship, Auditing, District Conventions, Ethics, Hall of Fame, Historian, International Send-Off, Logopedics, Membership & Extension, Music Education and Public Relations. Copies of these reports will be on file in the Secretary's office.

Supplemental <u>COMMITTEE REPORTS</u> were made as follows: <u>District Conventions</u>

Chairman McDermott distributed copies of the manual, dated December 4, 1983, entitled "Regulations Covering the Hidding Procedure for Pioneer District Conventions for Spring and Fall Contests." Upon motion by Director Goldschmeding, seconded by Director Schneider, by unanimous vote the Board adopted the Regulations as submitted. Convention Schedule

There followed a discussion of the convention schedule. The Board again stressed the requirement stated in the Regulations manual that "All Chapters submitting bids for contests and conventions <u>must</u> consult with the District Convention Planning Manager before the bid is submitted." The Board also emphasized the importance of the host chapters' having signed contracts with headquarters hotels and contest altes.

<u>Grosse Pointe - Spring 1985:</u> In a letter, dated February 14, 1984, to EVP McDermott the Grosse Pointe Chapter requested an advance of \$950.00 as a deposit on the auditorium because of a "critical cash flow."

In the discussion which followed certain pertinences were mentioned: that the District's Convention Manual provides "Cash advance for working capital is available from the District Treasurer <u>if needed</u>;" that the Gronge Pointe Chapter's 1964 show has provided that chapter with a good profit, most of which profit, according to the Ghapter President, had been earmarked for the chapter's uniform fund; that some of the District board members felt that care must be taken about setting precedents in granting cash edvance requests; that when cash advances are made, the possibility of assessing interest on them might be considered.

FRED WARING VOTED HONORARY MEMBER...

Director Jones then moved, with Director Tahrmatter providing the second, that the cash advance of \$950.00 requested by the Grosse Pointe Chapter be approved, with the advance taking the form of a deposit directly to the auditorium, payable in September 1984. The motion was disfavored by a majority vote.

<u>Traverse City - Fall 1985:</u> The Board re-examined the matter of the Traverse City Chapter's hosting the 1985 Fall convention, which was awarded to that chapter by the House of Delegates in its meeting of April 23, 1983. The Board's reconsideration was occasioned by the disclosure by Marty Chirgwin, Vice President of Division IV and a member of the Traverse City Chapter, that that chapter is having administrative, financial and membership problems which might affect its capabilities of sponsoring a convention at that time. At the request of the Board, for a report at the October 1984 meeting Mr. Chirgwin undertook to re-evaluate the situation, including the possibility of other chapters in the Traverse City area cooperating with the Traverse City Chapter in sponsoring the convention. <u>Swan Valley - Spring 1986:</u> Considering the bid of the Swan Valley Chapter to host the 1986 Spring convention, because of some question about the mitability of the auditorium accommodations, the Board voted to table action on the bid until its October 1984 meeting.

Contest & Judging:

Chairman King stated that he could not attend the Society's International Convention in St. Louis is July 1984. PRELIMS PROPAGATIONS

All the International Preliminaries are now complete, and here are the quartets which will be going to St Louis:

In the Evergreen District, PACIFIC PRIDE, the CASCADE CONNECTION. and the SOUTH SOUNDERS will all be returning to the International stage again this year. In Seattle, they were 17th, 44th and 27th respectively.

Dropping down to the Far Western District, the four qualifying quar-tets are 1) the KNUDSEN BROTHERS, 2) NEW TRADITION, 3) REMEMBER WHEN and 4) 139th STREET. This was a tough contest with the top 4 finishers being separated by only 17 points each having earned a score that would have placed them in the top 5 at Seattle. Three former FWD Champions did not make it to the coveted top 4 plateau. The KNUDSEN BROTHERS are new to FWD having joined the Phoenix Chapter in a transfer from the Rocky Mtn. District. They were 38th in Seattle, and moved up to take it all in San Jose - a much improved group! REMEMBER WHEN (8th in '83) is also from the Phoenix Chapter. NEW TRA-DITION is a "new" group made up of tenor, John Sherburn (Crown City Good Time Music Co. - Dist. Champs & Internat'l competitors and 5 years with the Dapper Dans of Disneyland), lead, Dan Jordan (Grand Tradition -4th at Internat'l in '80, '82 and '83), bari, Bob Gray, Jr. (also Grand Tradition), and bass, John Miller (Grandma's Boys, '79 Champs). The FWD Convention featured such unique things as a ROBOT for an MC! And, with the money they saved from his pay, FREE convention T-Shirts!

Speaking of Rocky Mountain District, their quartets will be the DUKE CITY QUARTET (44th in '81), and PARTNERSHIP (45th in '83).

Well they must have found a good replacement because they won the Illinois District Contest. Also earning the right to go to St. Louis was HEART OF CHICAGO, and AT EASE. The FOUR HENCHMEN is the alternate 4-some.

The Johnny Appleseed District will be represented by the RAPSCALLIONS, CINCINNATI KIDS and NEW REGIME.

If the Cardinal District could send 3 quartets instead of just 2, it still would not have made any difference -- they would ALL have come from the Louisville Chapter! The INTERSTATE RIVALS and the HAR-RINGTON BROTHERS will be making the trip, while the CLASS OF '84 will be standing by - all part of that THO-ROUGHBRED gang!

In the Seneca Land District, the EMPIRE EXPRESS is still chugging along, followed by the ESQUIRES, who just nosed out the NICKEL CITY HAR-MONY (40th in '82) by 4 points.

The Northeastern District will send three quartets this year. YES-TFRDAY BOUND was 1st, with ANYTHING GOES, the current District Champs, 2nd and FOURTIMES FOUR - 3rd. FAN-FARE is the alternate. I understand that those "four ol' guys," the TIMBRE JACKS, are reconstituted and singing again and would, perhaps, have won the contest but, for some reason, were not eligible to compete.

I almost skipped over the Ontario District where NORTHERN UNION and the REGAL ROGUES were the winners.

Dropping down to the Mid-Atlantic District, VAUDEVILLE (3rd in '83) led a group of seasoned competitors composed of SOUND REVIVAL (19th in '83), 4 UNDER PAR (29th in '83), the PROS 'N' CONS (13th in "83), ALEXAN-DRIA'S RAGTIME BAND, and the NEW YORKERS (16th in '83). Both VAUDE-VILLE and the BAND are from the Alexandria Chapter.

In the Dixie District, MIDNIGHT EXPRESS won the contest, followed by the STACKED DECK (27th in '82). A group with the interesting name of THE CRACKERLAND CHORD COMPANY is the alternate 4-some.

In the Sunshine District, GRAND CENTRAL (20th in '83) scored a convincing victory over TENTH PRECINCT. Down here it was the SUNSHINE CHORD COMPANY picked as the alternates. All these "companys" are just not making it - must be "Reaganomics!"

And talking about convincing victories - you can see by the score sheets that our CENTER STAGE were just that - convincing! The 'kids from Wayne,' the TRI-COUNTY CONNEC-TION, our current District Champs, will be making their first trip to International, while a new SATURDAY NITE FEATURE will be returning for another go.

Well, that's about it for the quartets. There will be just 47 this year, since neither GRAND TRA-DITION nor the ROARING 20's will be returning.

Just a couple of notes about the choruses - - in Pioneer, the LAKE-SHORE CHORUS of the Grosse Pointe Chapter won their very first Championship - of ANY kind - and they're all walking on air! Congratulations, men. Well Done!

In M-AD, the BIG APPLE CHORUS, performing at the Prelims, had 110 men on stage. They stopped their presentation to ask the audience if they would mind if another 28 more men, qualified but not yet in uniform, could join them. They are planning to have 140 men on the risers in St. Louis.

In SWD, the Small Chorus Contest was won by the SINGING PLAINSMEN of the Lubbock TX Chapter. One of the 29 men in the chorus was an exchange student from Sweden. We're truly becoming more International all the time!

Meanwhile, the winner of the SWD A.I.C. Scholarship this year was a young man named Todd Wilson, of the Dallas Metro Chapter. He's the son of Harlan Wilson, baritone of the SUNTONES - '61 Champions.

And finally, it's just about time to leave for chapter meeting....suppose you had a drive of SIX HOURS to look forward to? Robert W. Taylor lives in Henderson, Nevada, 270 mi. from Phoenix, and he's a member of the PHOENICIANS. "A part-timer," you say? Not at all! He has a 100% attendance record -- not only for regular chapter meetings but also for special show rehearsals. Now there's a man who's committed - or should be!

The Grosse Pointe Chapter is still stunned at seeing what "Gold" looks like up close for the first time since its origin in 1945.

The excitement, enthusiasm and electricity that accompanies these contests leaves little doubt that this one had to be a great head-tohead competition of the "also rans." With the Wayne and Grand Rapids Chapters not competing, it left the gates wide open for us and a few others who have been struggling to reach the top for so many years.

This was the year when quartets and choruses ignited the audience with exciting Sound and Stage Presence, and whether you came to enjoy the Harmony or be entertained, you saw and heard some great Barbershop singing. It took a lot of singing to get our Lakeshore Chorus a first place spot in a year when every chorus came charged and ready for combat.

Russell Seely, our energetic Director, should be given all the credit for bringing the chorus this far after so many disappointments. Had it not been for his devotion and determination, we would never have made it. True, he had help through the years from other directors, but nobody could get as much out of our men as Russ did. He has also been the backbone of our recent shows which have been real "crowd pleasers."

We have always been regarded as a "fun" chapter, but now the guys want more and they are thinking about representing the District at an International Competition - soon! We are hoping to enlarge our chorus by about half by next fall, which is a bigger task than we have ever attempted before.

Grosse Pointe first became a Century Chapter in the early 70's when we engulfed the old chapter that met at the Boat Club on Belle Isle, and since that time we've stayed quite near that mark. Each time a new chapter was formed nearby, we would lose a few, but now the guys are determined to go over the mark!

Grosse Pointe has contributed various parts to name quartets throughout the years and has continued to dominate the inter-chapter quartet contests we've had around the District, so a couple of years ago, we decided to venture outside the District and schedule a contest with the Maumee Chapter of Johnny Appleseed. Our third meeting is coming up on June 15 -- the series is even.

Grosse Pointe is also noted for its Father-and-Son combinations. We now have five: Russ and Matt Seely, George and Jerry VanDeVelde, Richard and Dale Barber, Jack and Mike Slamka, and Ron and Scott Houghton. Others from past years were: the Phelans, the Yacques and the the Reeds.

When Mark Roberts established this chapter, he had no idea it would make such a mark in the District's history.

When the 4-FITS were the District Champs, they vowed to visit every chapter in the District - and they did -- much to the pleasure of all concerned. They also represented Pioneer in Indianapolis, in 1975.

The meeting, held at the Briarwood Hilton Inn, Ann Arbor, Michigan, was called to order by President Gougeon at 9:08 AM.

Sergeant at Arms Dyer declared a <u>GEOREM</u> present. Mr. John T. Gillespis, International President of the Society, was present as a guest of the House.

Director of Music Education Stephens opened the meeting by leading the singing of "The Old Songs." Past President Warmer gave the invocation.

Upon motion duly made and seconded, the <u>MINUTES</u> of the meeting beld on October 15, 1983, were approved as distributed and published.

TREASURER'S REPORT: Treasurer Schneider submitted the Treasurer's Report, dated March 31, 1984, showing a balance of \$6,221.08 as of that date. Treasurer Schneider also submitted and explained a proposed Pioneer District 1984 <u>BUDGET</u> which, upon motion duly made and seconded, was approved by the House with no dissenting vote.

OFFICERS' REPORTS: Upon motion duly made and seconded and an affirmative vote of the House, the Officers' Reports as previously distributed were accepted in accordance with the "Consent Calendar" concept adopted by the House of Delegates in its meeting of October 15, 1983. Copies of these reports will be on file in the Secretary's office.

(At this point President Gougeon had to leave the meeting. The rest of the meeting was chaired by EVP McDermott.)

<u>COMMITTEE REPORTS</u>: It was stated that written reports from committee chairmen had been made to the Board of Directors at its meeting on April 27, 1984, and that copies of those reports will be on file in the Secretary's affice. Supplemental comments on their reports were made to the House by the chairmen of the following committees: Historian, International Send-Off, Membership & Extension, Public Relations and Troubadour Editor.

District Conventions - EVP Robert T. McDermott In its meeting of December 3, 1983, the District Board of Directors recommended to the House of Delegates that the bid of the Flint Chapter to host the District's <u>1986 Fall</u> <u>convention. October 17-19, 1986</u>, be accepted by the House. Upon motion by William F. Pascher, seconded by Eugene Hanover, the House voted to accept the bid of the Flint Chapter.

Chairman MoDermott reported that in a letter to him, dated February 14, 1984, the Grosse Pointe Chapter, as host for the 1985 Spring convention, had requested an advance of \$950.00 as a deposit on the auditorium because of a "Critical cash flow," and that the request had been disfavored by the Board of Directors in its meeting of April 27, 1984.

Mr. Harvey R. Burr, President of the Grosse Pointe Chapter, then explained the background for the request. The House suggested that the Grosse Pointe Chapter resubmit its request for the advance for consideration by the Board of Directors at its Fall 1984 meeting if the chapter still feels there is a meed at that time.

Area Counselor David Anderson suggested that the District re-examine that section of the Convention Manual in view of increasing expenses.

He alone is responsible for choosing the records to be reviewed in this column, and the colinions expressed are solely his.)

The Fresno Chapter was born April 14, 1958; to celebrate twenty-five years of harmony, Gold Note Chorus has released a record - "Do You Re-member When..." featuring the chorus and eight chapter quartets. For a good bit of variety and enthusiasm (while helping a good cause), you should consider buying this record. One of the strongest selling points of "Do You Remember When ... " is the variety. Six of the fourteen selections are performed by the Fresno Gold Note Chorus under the direction of Ron Black. The other songs are performed by eight of the chapter's quartets: Great Western Timbre Company, A Tonic Explosion, Gold West Four, Down from the Attic, Classic Rendition, Music Break, Finishing Touch, and Sierra Chord Express. (The Fresno Chapter earned the highest level in the Far Western District in the Society's Achievement Program during 1982; the quartets contributed to this success.) Even though some of the quartets are better than others, there aren't any bad ones.

The order of the songs on the record is well calculated to cause you to put it on the turntable and let it play, because the quartet songs are interspersed nicely between the chorus songs. There are contest songs from the Gold Note Chorus including, "If I Had My Way," "Do You Remember When," and the "Whippoorwill Medley," and a spiritual - "Let There Be Peace." The quartet selections include "Frog Kissin'," "A Child's Prayer," "From The First Hello," "Melancholy Baby," and others.

Another advantage of this record is enthusiasm. One of the problems at International and sometimes District contests is that the audience becomes quite bored by all the same songs sung by the almost interchangable groups. The difference oftentimes is enthusiasm. That's why the International guartet-finals sometimes can be more exciting than the finals -- the quarterfinalists don't all know they're supposed to be boring. All of that is to say there are no boring groups here. A couple of songs could be interpreted more satisfyingly, I imagine, but the oenjoying what they're doing.

There is one more point that I must make, however; that is that every group on the record is mediocre. If you're a member of Nostalgia.



that's not a criticism, but for other Barbershoppers, it may be. Although it consistently wins first place in its division, the Gold Note Chorus has never won the Far Western District contest. None of the quartets has ever won the District Contest, either. So, if you're looking for the whisper-soft to shouting-loud dynamics of the 115 man chorus or the smooth error-free execution of an International Champion quartet, forget about buying this re-cord. But if you're still a member of O.C. Cash's Society for the average, everyday, mediocre singer, then this is a record I think you should buy. There are probably few men on this record who sing much better than you or I sing, but then they don't sing any worse, either. This is really just a middle-of-theroad, Funky Winkerbean kind of pro-duct aimed at those of us who don't have to apologize for not being the best in the world.

The good cause of this record is that all of the profits will be donated to our International Service Project, the Institute of Logopedics in Wichita, Kansas. So, if you need to know that your money won't be frittered away, that should reassure you.


