What is this Chorus Plateau Award?

Many district members at the Spring Convention were asking about the significance of the chorus plateau award trophies which were presented for the first time at this contest. We hope the following will clarify the intent of the awards and how they were arrived at.

At the end of each year International publishes the number of members in each chapter in the District, and assigns each chapter to a plateau based on this membership figure. The plateaus are used for District Achievement levels, and it was decided by the District House of Delegates at our Fall Convention to use these figures for our own District Chorus Contest. The plateaus are determined as follows:

Plateau One -- Under 30 members

Plateau Two -- 0-39 members

Plateau Three -- 40-49 members

Plateau Four -- 50-74 members

Plateau Five -- 75-99 members

Plateau Six -- 100 or more mbrs.

It was decided by the delegates that rather than awarding the Gold and Silver trophies as we had in the past, that we would award a trophy to each plateau winner, that is, all chapters falling into a particular plateau range. Thus, small chapters would be competing against chapters of their own size with the hope that competition between chapters of equal size would spur more chapters to compete.

The overall champion chorus would be determined as it has in the past, and these additional awards are presented to supplement the other.

For the plateau awards, it was decided that rankings would prevail, so if a chorus, even though not eligible to win the overall contest, could still win the plateau award. This usually occurs when a chorus is disqualified because they do not have the required twenty men on stage. Thus, a chorus with only 15 men could win in their own plateau. It is an added incentive to get every chorus competing at the district level. A chorus would be defined as having a minimum of twelve members. We think this award system has a lot of benefits for our members. What do you think?



WE GET LETTERS

(The following letter was received by your editor from Les Lang, a long time dedicated Pioneer District and Flint Chapter member.)

Dear Bob.

Bill (Tobias) was an excellent editor and I'm sorry to see him go. I'm sure the "Troubadour" is in good hands again, as you have been an outstanding President, and will adequately fill his shoes. I know what a job editing a bulletin is, as I was the editor of the "Flint Notes" for ten years.

I had a heart attack at the Atlantic City Convention in 1970, but I continued to put out the bulletin until 1973, when I retired and moved to Florida for the winters. They didn't have a chapter where we stayed, but they had a few barbershoppers that met in a church just to woodshed and have fun. We each used to put in 50¢ every Monday night just to get music. I used to buy it from Kenosha for us. There were a few guys from our area that belonged to the Sarasota Chapter, and Fort Myers, too. We changed our meeting night to Wednesday so they could come. We ran an ad for singers in the local paper and we finally got about 35 guys together and organized the Charlotte County Chapter.

We put on a show every year and had the SUN TONES quartet on it for four years, plus the JOKERS WILD from Sarasota consisting of 3 of the HARMONY HOUNDS and Lee Frayer from Pontiac. We also had the MID-STATES FOUR formerly from Chicago and now from Orlando.

Cliff Douglas is singing in a quartet with Howard Hawkins, formerly of Lansing's MERRY MEN fame. (Ed. note: The quartet is named THE BACK PORCH MAJORITY, a name not unfamiliar in these parts.) Bud Carpenter, former member of the BEAN TOWN FOUR, is now in a quartet with the former bari of the AUTO TOWNERS, (Clint Bostic?) out of West Palm Beach.

I organized a quartet in the Charlotte County Chapter called the HARBOR LITES. We did a lot of performances for the retirees in the area.

I am now living with my son in Lapeer. I have poor circulation and emphysema, so I have problems getting around. As my wife died in 1981, my son didn't want me living alone, so I now have a nice 3 room apartment on the back of his home, and have my own furnace, bath, etc. I eat with them and am real comfortable.

March also saw twelve chapter members visit Swan Valley for a great workshop put on by Bill Meyer, a music specialist from International.




Remember When

(In recognition of our Society's up-coming 50th Anniversary in 1988, it was decided to run a series of articles covering the historical begin-nings of the Pioneer District. Many of our district members have no conception of what part our district played in the early days of our Society, so it is hoped that these articles will help many into a better understanding of the importance of our district in the formation of this great Society of ours.)

Memorial Day, 1939. Gathered for Detroit's annual Memorial Day parade on a Woodward Avenue corner, were several American Legion members. One group was enjoying a song when attention was called to a newspaper story about a convention and contest of the newly organized Society for the Preservation and Encouragement of Barbershop Quartet Singing in America, to be held in Tulsa beginning June 2nd. All had read about the formation of the new organization and several were interested in getting more information about the Society. Ed Schwoppe, of the Michigan State Highway Department, member of a quartet known as the STATE HIGHWAY FOUR, said he'd "go down there and investigate."

Schwoppe made the trip to Tulsa with Harold Gibbs, then of Traverse City. At the meeting held in the Hotel Tulsa on June 2, 1939, a national organization was created with Rupert Hall, of Tulsa, as president. A vice president was named from every state represented, "to be in charge of development." Ed Schwoppe was named as the vice president from Michigan.

On Sunday, July 30, 1939, a group of twenty men met in the cottage of William Barry at Lake Orion. The story of SPEBSQSA and the convention doings was related to them. At that meeting the Detroit Chapter was organized and a charter was applied for, the first in Michigan and the first east of the Mississippi River. Elected as officers were Joseph Wolff, president, Howard Tubbs, vice president, William Barry, master of ceremonies, and Glenn Shields, secretary and treasurer.

Chorus Competition-On Stage Time

The International Contest and Judging Committee has spent a considerable amount of time on the concern of increased riser decoration and elaborate staging preparations in competition. We are experiencing delays in the chorus contests because of the extended preparation.

Our major concern is the effect of delays on competitors, audiences and overall convention schedules. A singing order and schedule are pub-lished in advance of the contests.

HOTEL

TIME

This provides a guideline for the preparation toward a peak performance on stage. You can understand that delays in the contest will disrupt this schedule and create a negative impact on competitors singing later in the contest.

The International Contest and Judging Committee's responsibility is to protect the rights of all competitors and assure them of a fair opportunity toward a best performance. Yet, the committee is reluctant to

legislate against creativity on the contest stage. As a result, we are appealing to all competing chorus leadership to plan onstage time not only to adhere to published convention schedules, but also to respect fellow competitors and convention audiences.

We are also asking district C&J chairman to provide data on chorus preparation by timing backstage preparation. This timing is for information purposes only and will not threaten your competition performance

Please understand that the Contest and Judging Committee has no desire to legislate against this showing of creativity, but we cannot shirk our responsibility of fairness to competitors and audiences. We feel these extended delays are unnecessary and hope this special notice will notify all competitors and enlist your cooperation in preventing another set of rules.

Public Domain Songs

by Joe Liles

In reading articles from district and chapter bulletins, I detect some misunderstanding concerning songs in public domain. Songs over 75 years old do become public domain, but arrangements of those songs are still under copyright protection.

This means only the melody line and lyrics (words) are now free property. After 75 years a melody and lyrics of the song can be used on song sheets or by arrangers wishing to make their arrangement. Arrangements of those songs are protected as if they are original property and hold all the protection listed under Copyright Law. This includes arrangements copyrighted by S.P.E.B.S.Q.S.A. It is unlawful to copy copyrighted arrangements to the tune of \$10,000 per copy. It is much cheaper to purchase them!
